This checklist provides a step-by-step guide to evaluating and assessing your security systems, based on the latest trends, regulations and "SIRA Guidelines" in Dubai.

1. Surveillance & Monitoring - CCTV Systems

- Are all critical entry points and high-risk areas covered with the correct camera for the location and required coverage?
- Does your existing Surveillance System adhere to industry- and regulatory standards?
- Are your security cameras strategically positioned to avoid blind spots?
- When was the last time your security systems been evaluated to optimize the coverage for current operational and/or regulatory requirements?
- Do you have the required Video Guard systems in place, registered and active as per SIRA regulations?
- Has your current security systems service provider been evaluated and found compliant and certified?
- Is your security system being regularly maintained and upgraded to adhere to current standards and regulatory requirements?





2. Access Control Systems

- Does your business operate using an operationally sound Access Control and Access Management system best suited for your business or premisses?
- Are restricted areas properly secured with role-based access?
- Is there a real-time tracking system to monitor entry- and exit logs, and provide incident notifications and proper reporting for evaluation and/or time and attendance information?
- Are doors equipped with fail-safe mechanisms in case of power failures?
- Is access control integrated with FLS and Emergency systems?
- Have employee access permissions and credentials been reviewed and updated regularly?

3. Alarm & Intrusion Detection Systems

- Has the need for an Intruder Alarm System been assessed (if not from an operational/company standards standpoint then from the latest insurance or regulatory agencies approvals requirements)?
- Are properly designed or updated systems with sensors installed at currently relevant and key locations?
- Is there an instant alert system that notifies security teams, building Management or assigned personnel of breaches?
- Is the system connected to a 24/7 notification, response or monitoring service for emergency response?
- Has the alarm system been tested to prevent disruptions in the last 3 months?
- Are alarm systems integrated with other security solutions (e.g. CCTV, access control)?





4. Additional Security Measures to Consider

- Do employees undergo security systems awareness training on access control and data protection?
- Are visitor management policies enforced to prevent unauthorized access?
- Is there an efficient backup power system for security infrastructure during outages?
- Has the business undergone a security risk assessment in the last 12 months
- Are cybersecurity measures in place to protect IP cameras and access control systems from hacking?
- Have employee access permissions and credentials been reviewed and updated regularly?
